

# VACANCY PETERHEAD PORT AUTHORITY

Job Title: Quality Assurance Officer

The Port of Peterhead is the most easterly deep-water harbour on the Scottish mainland and lies close to the oil and gas fields of the Northern and Central North Sea. The harbour consists of Peterhead Bay, a natural inlet protected from the sea by two breakwaters and the inner harbour which consists of a series of harbours and basins that provide facilities for the North Sea fishing industry.

Peterhead is one of Europe's largest fishing Ports. The inner harbour provides modern facilities to handle all aspects of the industry. Facilities include Port Henry Marina for small commercial fishing vessels, temperature-controlled Fish Market, Slipway that can accommodate four fishing vessels, Shiplift for maintenance and repair of two vessels, Drydock, Maintenance Workshop and an Ice Factory. Additional external facilities to Peterhead Port Authority include net repair facilities, fish box provision, freshwater and fuel.

There are three areas dedicated to energy industry service and logistics from:-

- Smith Quay / Merchants Quay at the mouth to the inner harbour,
- The North Base consisting of land space hosting storage and warehousing including the North Breakwater.
- The South Base consisting of the South Breakwater, land and warehousing and the Princess Royal Jetty.

The Tanker Jetty is located close to the South Breakwater and was built to import fuel to the nearby Peterhead Power Station. The Jetty is designed to accommodate tankers up to 40,000 dwt but is also used for offshore industry vessels and cruise liners.

Peterhead Leisure Marina is situated in the south-west of the bay and provides pontoon berthing for 160 leisure craft.

## Job Description:-

As a Quality Assurance Officer at our port facility, you will play a vital role in maintaining and improving the quality standards of our operations. You will be responsible for implementing quality assurance processes, conducting inspections, and ensuring compliance with regulatory requirements connected to the Fish Market and wider port operation. Your attention to detail and analytical skills will be instrumental in identifying areas for improvement and implementing corrective actions to enhance overall efficiency and safety within the port environment.
